## Literacy for All Equitable Practices for Reading & Dyslexia

**WHO:** National Center on Improving Literacy (NCIL), Decoding Dyslexia Maryland (DD-MD), WETA/Reading Rockets and Advocacy Day Community Partners

**WHAT:** Reading proficiency for students is a critical issue in Maryland. Preventing reading difficulties and providing help for students with reading difficulties is also a critical element of the “Blueprint for Maryland’s Future.” Early literacy and dyslexia experts from NCIL will explore best practices in literacy with local school districts, parents & advocates.

**WHEN:** Thursday, February 20, 2020 from 8am -2pm

**WHY:** Strong reading skills developed in early elementary school are a prerequisite for students to be college and career ready by the end of the 10<sup>th</sup> grade and a key goal of the “Blueprint for Maryland’s Future.” 2019 MCAP results show 42% of 4<sup>th</sup> graders and 43% of 10<sup>th</sup> graders were proficient on the English Language Arts test section.

Teaching students to read is the first job of our schools. Teachers, administrators and parents will explore how to identify students who may be at risk of reading struggles in pre-k and early elementary school. They will discuss best practices for teaching all students to read, including those who struggle and need additional interventions. This information will be helpful for school districts implementing Kindergarten reading screening in 2020-2021 and implementation of the Blueprint for Maryland’s Future.
